General Description:

The THICKSET® 90 Series glass block windows are installed in place, block by block using vinyl (PVC) plastic spacers and silicone. The product is intended solely for residential installations. The glass block windows are anchored to the structure with a rigid vinyl (PVC) channel. This evaluation report includes the following THICKSET® 90 Series glass block windows:

Window Dimensions:

- 4' x 4' window
- 4' x 8' window

Glass Block Patterns and Dimensions:

- Nubio[®]; 8" x 8" x 4"; 3/4" face thickness
- Nubio[®]; 6" x 6" x 4"; 3/4" face thickness
- Clarity®; 8" x 8" x 4"; 3/4" face thickness
- Clarity[®]; 6" x 6" x 4"; 3/4" face thickness
- Endura®; 8" x 8" x 4"; 3/4" face thickness

Product Identification: The glass block windows are identified from the carton label. The words THICKSET® or THICKSET® 90 follow the name of the pattern.

Limitations:

Design Drawings:

Glass block window assemblies must comply and be installed in accordance with the following design drawing:

Drawing No. RHRW-001; "Residential Hurricane Resistant Windows with THICKSET® 90 Series Glass Block and ProVantage® Silicone System;" Sheets 1 thru 3 of 3; dated November 17, 2015; signed and sealed by Hermes F. Norero, P.E on March 08, 2017. This evaluation report refers to the stated drawings as the approved drawings.

Fabrication and Assembly: The glass block assemblies are fabricated in the factory. The glass block assemblies are installed at the jobsite block by block.

Design pressure (DP):

 The allowable design pressure rating for the glass block assemblies is specified on the design drawing. The maximum allowable design pressure rating is +100 / -100 psf. Refer to approved drawing for specific design pressure requirements.

Impact Resistance:

The glass block assemblies satisfies the TDI's criteria for protection from windborne debris in both
the Inland I and Seaward zones. The assemblies passed a large missile impact test equivalent to
Missile Level D specified in ASTM E 1996. Install these assemblies at any height on the structure
that does not exceed the assembly's design pressure rating. These assemblies do not require
protection with an impact protective system when installed in areas that require windborne
debris protection.

Acceptance of Other Assemblies:

- The approved drawings specify the allowable dimensions for the glass block assemblies.
- Assemblies with rectangular dimension smaller than the dimension listed in the approved drawings are acceptable at the design pressure rating listed in the approved drawings.

Installation Instructions:

General: Prepare and install the assembly in accordance with the approved drawings and the manufacturer's installation instructions. Detailed installation instructions are available from the manufacturer.


Installation:


Wall Framing Construction: The glass block assemblies must be secured to the wall framing as specified in the approved drawings.

Fastener Requirements:

- Refer to the approved drawings for the anchor requirements and notes.
- Refer to the approved drawings for the minimum embedment depths for the fasteners and the minimum edge distances (minimum distance fastener must be from the edge of the substrate material) for the fasteners.

Note: Keep the manufacturer's installation instructions and the approved drawings available at the job site during installation. Use corrosion resistant fasteners as specified in the IRC, the IBC, and the Texas Revisions.

SPECIFICATION NOTES:

- GLASS BLOCK UNITS: Thickset ® 90 Series 8"x8"x4" or 6"x6"x4" (nominal size).
- FRAME AND SPACERS: Extruded white rigid PVC. Frame corners are cut square or mitered and are silicone sealed. Extruded by Cardinal Systems, Inc.
- SEALANT: Seves Glass Block Sealant. One part neutral fast curing structural silicone sealant.
- **SEALANT LOCATIONS:** All horizontal and vertical glass block joints; inside corners of perimeter channels; two beads (\(\frac{1}{2} \)" from each edge) between back of perimeter channels and framing members; two beads each above and below "long" horizontal spacer and "short" vertical spacers; perimeter joints between glass block and channel legs; and perimeter joints between channels and framing members.
- REINFORCEMENT: PVC spacers between all horizontal and vertical joints. Spacers in channels are not required.
- SHIM SPACES: Maximum $\frac{1}{4}$ " shim space between the perimeter channel and wood frame.
- FIELD INSTALLATION: Loose materials (glass block, spacers, channels and sealant) are available from Seves Glass Block authorized distributors, dealers and home centers for on-site installation.

 Complete window units, framed within 2x6 treated lumber, and pre-fabricated by Seves Glass Block in accordance with these instructions, are also available from authorized distributors, dealers and home centers. NOTE: These windows are recommended for RESIDENTIAL APPLICATIONS ONLY.
